1. Reproductive and child health programme : RCH programme being one of the oldest in NHM but lacks in funding in different ways creates problems in many scenario and one important point highlighted in this meeting is the need for Half yearly Review meeting was discussed in this meeting. So, the committee votes that plans be made and submit to the Chairman, District Health Team for funding by the DHT.

2. IDSP: IHIP reports are submitted on timely and no problems have been identified by the DDM, IDSP.
