The meeting was conducted by the convener and few points from the previous meeting were highlighted, the convener invites the member secretary to move on with the meeting. In this meeting HMIS report for the month of October, 2023 was analyzed and the following points are highlighted in the meeting as well as action points to be taken.

1. Antenatal registration in 1st trimester: Total ANC registration for the month of October is 117. Out of this, registration within 1st trimester is only 59.9%.

Amongst the 35 HWC and SCs there are 5 facilities who performed very poor, viz,.

1. Hmunlai HWC 0%

2. S Lungpher SC 0%

3. Vaseitlang HWC 0%

4. Vathuampui HWC 0%

5. Tuithumhnar HWC 20%

It can be seen that, out of 5 facilities with low performance in the 1st trimester registration of pregnant women, 4 of them are HWC posted with HWO/MO Ayush, it seem that these facilities needs to try and improve regarding this indicator, and Supportive supervision and monitoring is badly needed.

2. IFA 180 tablet distribution:- out of the total ANC registration only 66.6% received IFA 180 tablets during October, 2023.

- 4. Deliveries: The total Home delivery is 41.8% % and the institutional delivery is 58.20%. In this the institutional delivery is slightly lower than the previous month, but regarding last year and the previous year we have seen improvement in institutional delivery
- 5. Home Based Newborn Care (HBNC): The total HBNC achievement is 58.20%. a slight improvement is seen in this, out of total home deliveries only 57.14% received HBNC and out of total institutional deliveries only 39.74% received HBNC.
- 6. Fully immunized below 1 year of age: the district achievement regarding this indicator for the month of October 2023, is 122% against live birth which is very good, and hope to remain the same for the coming months.
- 7. Grievance redressed During this meeting grievance about HMIS report uploading is addressed, this is mainly due to current electricity and internet connectivity.
