The meeting was conducted by the convener and few points from the previous meeting were highlighted, the convener invites the member secretary to move on with the meeting. In this meeting HMIS report for the month April 2023 to March 2024 was analyzed and the following points are highlighted in the meeting as well as action points to be taken.

1. ANTENATAL REGISTRATION IN 1ST TRIMESTER: District 1st Trimester ANC registration for the year 2023 - 2024 is 61.82%, which is a bit lower than the year 2022-2-23 (65.5%). The following facilities are having the lowest performance.

It is very clear that the HWO posted in these facilities are not performing as expected, it seem that these facilities needs to try and improve regarding this indicator, and frequent supportive supervision and monitoring is needed.

2. IFA 180 TABLET DISTRIBUTION: Out of the total ANC registration 59.5% received IFA 180 tablets during this financial year. Which is a bit higher than last year, which is 52.1%

3. COMPLETE/4ANC: The district achievement for this is only 45.65% which is a bit higher than the previous year (37.4%) and very low as a district since most of the Sc's are upgraded to HWC posted with HWO/MO Ayush.

4. DELIVERIES: Total delivery for this financial year is 2309 and Home delivery is 31.40% and institutional delivery is 68.60% which is much higher as compared to the previous year (59.2%). This is a tremendous improvement for Lawngtlai district and the main reason behind this is the newly trained SBA which takes place last year. New HWC staffs who have not been trained last year also needs SBA training thus for the improvement in institutional delivery in the future. Proposal be made for SBA training to DHT for the left out staffs.

5. HOME BASED NEWBORN CARE (HBNC): Achievement on 7 HBNC visits is 58.76% and 6 HBNC is 36.67% which is an improvement as compared to the previous year, yet needs to improve.

9. FULLY IMMUNIZED BELOW 1 YEAR OF AGE: the district achievement regarding this indicator for the financial year is 74.8% against live birth which is slightly lower compared to the previous year (80.8%).

10. IDSP - Lawngtlai district ranked 1st in IHIP reporting again and the members congratulate the DDM, IDSP for his continuous good performance and hope to do well in the future as well.

11. Grievance redressed – During this meeting one grievance was discussed i.e monitoring and supervision of RCH programme on those facilities with low performance. Proposal have already been made to the DHT but no yet approved. This issue will be raised again in the next DHP meeting.
