The meeting was conducted by the convener and few points from the previous meeting were highlighted, the convener invites the member secretary to move on with the meeting. In the meeting, NCD report for the month May 2024 was analyzed and the following issues are highlighted as well as action points to be taken.

1. Community Assessment Checklist (CBAC): Out of 35 HWC/SC, 15 HWC/SC have completed filling CBAC form and uploaded in NCD portal. 10 HWC/SC have attained more than 50% and the other 10 HWC/SC have attained below 50%. As Jarulsury SC is vacant for a long time, the achievement is 0% till date. The following are the HWC/SC who haven't attained 50% in filling up CBAC form:

It is seen that Jarulsury SC has zero achievement since the beginning, it is due to the absence of Health Worker in the SC. Also, in Borapansury SC, there is no Health Worker posted in the SC and there cannot be proper achievement. The rest of the low performing HWC/SC are posted with CHO/HWO/HW. However, Chawngte C HWC is having a very large population of 14152 with only one Health Worker and one Community Health Officer which makes it difficult to have a remarkable achievement.

- 2. Screening: Out of 35 HWC/SC, only 8 HWC/SC have achieved 100% in screening of Diabetes Mellitus, Hypertension, Oral Cancer and Breast Cancer. They are:
  - 1. Diltlang HWC
  - 2. Mautlang HWC
  - 3. Hmunlai HWC
  - 4. South Lungpher HWC
  - 5. Siachangkawn HWC

- 6. Cheural HWC
- 7. Lungtian HWC
- 8. Pangkhua HWC

The other 12 HWC/SC have achieved more than 50% in which some of them have almost attained 100% and the other 15 HWC/SC are still below 50%. The overall achievement is 43.11%. The low performing HWC/SC in screening of DM, HTN and Cancers are:
