The meeting was conducted by the convener and few points from the previous meeting were highlighted, the convener invites the member secretary to move on with the meeting. In this meeting HMIS report for the month April 2024 was analyzed and the following points are highlighted in the meeting as well as action points to be taken.

1. ANTENATAL REGISTRATION IN 1ST TRIMESTER: District 1st Trimester ANC registration for the month of May 2024 is 64.95. The following facilities have the lowest performance as follows.

1. Saizawh HWC 33.3% 2. Sangau HWC 33.3% 3. Damdep HWC 20% 4. Mautlang HWC 0 5. Diltlang HWC 0

> It is very clear that Mautlang HWC and Diltlang HWC still have Nil performance in 1st ANC eventhough HWO are also posted in these facilities , it seem that these facilities needs to try and improve regarding this indicator, and frequent supportive supervision and monitoring is needed. Hence the committee suggested that order be issued regarding this topic and give to Mautlang and Diltlang HWC.

3. COMPLETE/4ANC: The district achievement is only 38.66% eventhough Sc's are upgraded to HWC and posted with HWO/MO Ayush.

There are 18 facilities with below 50% achievement regarding this indicator, namely,

- **4. DELIVERIES:** Total Home delivery is 27.55% and institutional delivery is 72.45 % which is much higher as compared to last month. SBA training is still needed for the improvement in institutional delivery in the future. Proposal be made for SBA training to DHT for the left out staffs.
- **5. HOME BASED NEWBORN CARE (HBNC):** Achievement on 7 HBNC visits is 92.59% and 6 HBNC is 54.22% which is an improvement as compared to last month, yet needs to improve.
- 6. FULLY IMMUNIZED BELOW 1 YEAR OF AGE: The district achievement regarding this indicator for the financial year is 61.65% which needs improvement.
- 7. Integrated disease surveillance programme (IDSP)/IHIP
 - IHIP yearly reporting performance (2023 2024): The overall reporting percentage is 99.89% ranking 1st in the State. Reporting percentage of S,P & L forms are 96.97%, 100% & 100% respectively. The performance of the district is highest in all three forms of reporting within the State.
 - a. S form: There are 33 reporting health facilities including Sub-Centres and Sub-Centre-Health and Wellness Centres (SC-HWC). The common diseases reported are fever (5858) and cough (629). A total of 11958 cases are reported under various syndromes.
 - b. P form: There are 9 reporting health facilities including PHC, DH and Private hospitals. The common diseases reported are fever (2521), malaria (5174), scrub typhus (1031), typhoid (1869) and other diseases.
 - c. L form: The reporting facilities are similar to P form reporting and the common cases reported are 1399 cases of malaria out of 8624 samples tested, 659 cases of scrub typhus out of 3963 samples tested and 1228 cases of typhoid out of 5007 samples tested.
 - The cases of malaria, scrub typhus and typhoid are highly endemic during monsoon season therefore there is rise in reporting and detection of such cases.
 - 2. Grievance redressal: During monsoon season majority of reporting is hampered due to network problems especially in the remote rural areas.
 - 3. 1. Many of the reporting facilities are still facing the issue of bad network especially during rainy days and in the absence of proper power supply. Best efforts are still given to address these issues from the district District Surveillance Unit (IDSP).
