The meeting was conducted by the convener and few points from the previous meeting were highlighted, the convener invites the member secretary to move on with the meeting. In the meeting, HMIS report for 1<sup>st</sup> quarter 2024 (April – June) was analyzed and the following issues are highlighted as well as action points to be taken.

**1. ANTENATAL REGISTRATION IN 1<sup>ST</sup> TRIMESTER:** District 1<sup>st</sup> Trimester ANC registration for the 1<sup>st</sup> qtr 2024 is 67.22%, which is a higher than the year 2023 - 2024 is 61.82%,. The following facilities are having the lowest performance.

It is very clear that the HWO posted in these facilities are not performing as expected, it seem that these facilities needs to try and improve regarding this indicator, and frequent supportive supervision and monitoring is needed.

**2. IFA 180 TABLET DISTRIBUTION:** Out of the total ANC registration 51.2% received IFA 180 tablets during this financial year. Which is a bit higher than last year, which is 59.5%

**4. DELIVERIES:** Total delivery for this quarter is 532 and Home delivery is 30.4% % and institutional delivery is 69.54% which is higher as compared to the previous year (68.60%). This is a tremendous improvement for Lawngtlai district.

**5. HOME BASED NEWBORN CARE (HBNC):** Achievement on HBNC visits is 77.1% which is an improvement as compared to the previous year, yet needs to improve.

**6. FULLY IMMUNIZED BELOW 1 YEAR OF AGE:** the district achievement regarding this indicator for the financial year is 78.6% against live birth which is slightly lower compared to the previous year (74.8%).

**7.FPLMIS apps** was discussed and it was known that Lawngtlai District performance is one of the lowest and the main reason was ASHA and Health worker needed re-orientation. So,the committee passed that Orientation training on FPLMIS or all programmes be plan and submit to DHT Chairman for funding.

**8.Grievance redressal :** No grievance has been received on this month.
