The meeting was conducted by the convener and few points from the previous meeting were highlighted, the convener invites the member secretary to move on with the meeting. In the meeting, Malaria report from April – August was analyzed and the following issues are highlighted as well as action points to be taken.

1. TOTAL TESTED:

District total diagnosis/tested is 29107 from April till August 2024 which is lower than Last year positive cases.

2. POSITIVE CASES:

A total of 5711 positive cases was identified in the District. Total PF cases is 2267 and total PV cases is 3444 which is higher than last year positive cases. From April till June positive cases reported were higher than last year but from July till date the positive cases reported are higher than last year. ASHA's should also carry malaria test kit when they go for home visits like HBNC, HBYC etc.

3. DEATH CASE:

A total of 7 deaths have been reported and audited during this period. Death case are lower than last year. From this reported cases there are 3 cases of Child Death due to Malaria.

4. INDOOR RESIDUAL SPRAY:

IRS 1st Round has been done during June and overall performance is 87% of total household i.e 24147. IRS 2nd Round will also be done during September 2024. 1st Round performance is low in Parva, Chawngte 'C', Devasora, Jarulsury, Sub-Centre due to inadequate staff at SC. Saizawh West performance is also low due to poor performance from the sub-centre staffs.

5. IHIP MALARIA Performance:


In IHIP portal Malaria component there are some issues as well as low performing facilities like District Hospital and Christian Hospital Lawngtlai. From the Sub-centre's Longpuighat and Lungtian are the poor performing facilities.

It is very clear that the HWO posted in these facilities are not performing as expected in terms of Malaria since they think that it is mainly the Health Worker job, it seem that these facilities needs to try and improve regarding this indicator, and frequent supportive supervision and monitoring is needed from Malaria Technical Supervisor.

8. Grievance redressal : No grievance has been received on this month.
